What is the VALUE YOU PLACE on a Child's Life?
Dr. Allan Cohen describes what he means by "Prevention".

There are three stages at which we assist people -Treatment and Rehabilitation is the last stage, Early Intervention is second and Prevention is first.

Our country has not focused enough on prevention - when you work with individuals who have never used drugs or alcohol and those who have experimented but do not habitually use them.

Drugs and alcohol are such a big factor in our society that I think it's the parents' and school's and church's responsibility to let teenagers know what the facts are. The facts and information about the effects of chemicals and the proper use of medical chemicals is very important. But a knowledge of these alone may not change behavior. What we haven't done well enough is to show how there are styles of life and activities that are as fullfilling as pleasurable, and in the long term much more constructive than drugs. It's enjoying and feeling good about relatively normal activities that breed self-confidence and self-reliance and that allow teenagers to grow up in healthy ways.

One program in which kids are helping themselves is called 'Peer Counseling'. In school teens often feel funny about approaching Guidance Counselors - so kids are trained to listen. Its kid helping kid. It seems to be very effective - for the counselors as well as the counselees.

Another program suggests the seniors and juniors teach 7th and 8th graders - giving the younger people - role models to work with.

One program called 'cross-age tutoring - has student volunteers go into elementary school and tutor younger kids who are having problems with

their subjects.

Still another program had kids setting up tourist centers, restoring historical landmarks and conducting businesses in their community showing youth can do constructive jobs. Adults have to provide the environment in which good prevention programs happen and let the kids do it.

NOONTIDE HOUR OF PRAYER

In so-called underdeveloped countries the youth are given a lot of responsibility. They believe that the more responsibility you have the more meaning your life has because people depend on you. They believe you and then are less likely to fool around with substances that are going to effect your judgement and rendor your body less able to defend itself.

This philosophy works because they have much less of a problem with drugs and alcohol than we do - especially among young people.

## FROM YOUR LEGISLATION & CITIZENSHIP DIRECTOR

Dear Union President and Members:

Another letter from Mrs. Peck came a couple of days ago. As you can see, a bill (HR 2526) has been introduced which will make it mandatory for radio and TV stations to provide equal broadcasting time on the "various adverse effects of alcoholic beverage consumption and misuse". That means, for every minute of beer and wine commercials, the station must also give a minute of public service time to tell of the hazards of alcoholic beverages.

Mrs. Peck's letter gives us instructions as to what we are to do now. Please read it carefully and get your members to carry out a letter-writing

campaign.

Also note her last paragraph and write to Senators and Congressmen to support the respective bills which will establish PERMANENT PROHIBITION on the FEDERAL FUNDING of abortions unless the life of the mother is in danger. Sincerely.

# LEGISLATION - CITIZENSHIP **NATIONAL WCTU**

Dear Directors, Presidents, National officers,

State Editors and others:

You have labored almost a year on petitions to Stop Marketing Alcohol on Radio and Television. CONGRATULATIONS on your valiant efforts. (If you still have signatures not mailed, still mail in to: Project Smart, P.O. Box 19125, Washington, D.C. 20036)

WHAT NOW? Ohio Representative John Seiberling introduced HR 2526 in the U.S. Congress on May 15. This bill was referred to the HOUSE ENERGY AND COMMERCE COMMITTEE of 42 members. However, the Sub Committee of TELE-COMMUNICATIONS IS ASSIGNED THIS BILL

FIRST.

HR2526 does not call for an outright ban on alcohol advertising, but does mandate that radio and television stations must provide equivalent broadcasting time on the "various adverse effects on individuals and the public generally that may be attributable to alcoholic beverage consumption and misuse". In other words, for every minute of beer

and wine commercials, the station must provide a minute of public service time to tell of the adverse health, economic, social and personal hazards of

alcoholic beverages.

Why ask for equal time rather than an outright ban on advertising? There are several good reasons for this strategy: 1. Demanding equal time avoids the "freedom of speech" issue. The alcohol and broadcasting industries have been saving that a ban violates their first-amendment rights of free speech. 2. Banning radio and TV advertising would only release industry money for other forms of advertising, e.g., newspapers, magazines, bill-board, etc. 3. Asking for equal time will get the message out on the adverse effects of alcohol. Many persons believe that the alcoholic beverage industry will voluntarily withdraw media advertising rather than stimulate anti-alcohol commercials. 4. "Equal time" is politically more feasible.

A massive letter writing campaign is needed NOW from all parts of the country. We are up against two powerful, well-organized and rich industries - the networks and the alcoholic beverage fraternity. They are already at work. The only thing that will counteract their lobbying efforts in Washington, D.C. is a huge groundswell of public opinion from the grass roots. Nearly a million citizens have signed petitions against alcohol advertising. Now they need to write to their

Representatives in Congress.

Polls show that 57 percent of our Nation would favor such legislation. Remind the Congressman of that, plus the 100,000 deaths and \$120 Billion economic loss annually. Cite the factors of crime, suicide, broken homes, child abuse, etc.

Ruby Grubb of PA., writes that she watched the hearing as a rerun on C-span for several hours and one of the questions asked was whether alcohol is intrinsically harmful. She says, "No one answered this question satisfactorily.'

## REPORT ON BISMARCK DISTRICT CONVENTION - MAY 28, 1985

Twenty-three registered at the 86th annual Bismarck District Convention held May 28, 1985, at the Bismarck Veterans Memorial Library. Edna Jenson presided and gave the welcome. Rev. Delmar Becker sang "Christ Is All In All". The Scripture was John 3:16, 17, 18 and John 9:39. Memorial Day honored the servicemen who gave their lives for their countyry. Several accounts of Christians who died "in action" were given from Fox's Book of Martyrs compiled in 1519 by John Fox. Hebrew 11 known for its list of people of faith also tells of the death of martyrs. Jim Eliot, modern day martyr, gave his life to reach the Auca Indians of the jungle. Later his wife lived with the Aucas and saw them accept Christ. We may have some defeats, but we really live in comfort and are not really martyrs. Where are we in the battlefield for the Lord?

Emma Blattner led in the pledges to the flags. Edna Jenson reported on the mid-year meeting and announced the State WCTU Convention to be at the Comfort Inn in Bismarck Sept. 26 and 27, 1985.

Thelma Klingensmith reported she attended all but 5 of the 62 days of legislature. She was sustained by daily prayers of people across the state. When a Bismarck salesclerkasked why she had to work on Sunday, Thelma checked and learned in last days of legislature the Sunday closing bill was quietly and unknown to many brought back and amended to allow 6 employees and manager to work in stores (mostly food and entertainment) on Sundays. Passed with emergency clause, it became a law when signed by governor. Some cities have passed ordinances to protect Sunday a family day, some people have signed petitions of disapproval of Sunday opening and-or suggested boycott of such stores.

Both unions reported using YYE inserts in bulletins and giving out WCTU literature. Steele reported enhancing their meetings with many Bible verses on Service (theme for this year).

Olga Huhncke read from Psalm 116 for the Memorial Service for Emma Kapp of Steele Union and Vendle Vitalis of Bismarck Union (who recently had been living with a sister in Minnesota). Both had been teachers and despite much suffering had been a blessing to others.

After dinner was served by Bismarck Union, Captain Richard Rubottom of Bismarck Salvation Army led in afternoon devotions. After reading Deuteronomy 4, he talked about Christian illiteracy of the Bible especially of the Old Testament, yet the Old Testament was the Scripture of the early church and what Paul referred to in II Timothy 3:16.

Elizabeth Lind sang "Haven of Rest".

Captain Larry Everson (member for 25 years in the Highway Patrol) showed the film "One for the Road", narrated by Boyd Christenson. This

summer the 50th anniversary of the N.D. Highway Partol is being noted. Alcohol is involved in 63 percent of highway deaths. He gave out stickers for REDDI (Remove Drunk Drivers Immediately) with phone numbers to call when seeing erratic driving (1-800-472-2121).
