# Governors to discuss national water policy

The Carter Administration's developing water policy will receive the attention of 10 governors of Missouri River Basin states May 23-24 in Great Falls, Mont.

The governors will be holding their third annual Missouri River Basin Governors' Conference at the Heritage Inn in conjunction with the 24th regular quarterly meeting of the state-federal Missouri River Basin Commission.

States which are members of the commission and which will be represented at the conference are Colorado, Iowa, Kansas, Nebraska, Minnesota, Missouri, Montana, North Dakota, South Dakota

and Wyoming.

Host Gov. Thomas L. Judge of Montana will serve as conference chairman.

The conference will begin with registration from 1 to 6 p.m. and a reception at 5:30 p.m. Tuesday, May 23. A general session is scheduled at 8:30 a.m. Wednesday, May 24, followed by a joint conference and Missouri River Basin Commission luncheon at noon.

One objective of this year's conference is to provide an opportunity for the governors to exchange views with representatives of the Carter Administration on recent federal initiatives to develop a national water resources policy, update Indian water rights policy and reorganize the federal natural resources establishment.

Governor Judge said he was "delighted the Missouri River Basin Governors were meeting in Montana. I am confident that the issue of water policy, so critical to the states involved, will be given thorough and meaningful attention at this meeting," he said.

Two administration representatives will meet with the governors in the general session May 24. A third representative will speak at the luncheon.





### Governors to discuss national water policy (continued)

Guy R. Martin, assistant secretary for land and water resources in the U.S. Department of the Interior, will discuss President Carter's national water resources policy recommendations. Martin also serves as alternate to the chairman of the U.S. Water Resources Council.

Forrest Gerard, assistant secretary for Indian affairs in the U.S. Department of the Interior, will discuss the administration's review of Indian water policy.

William W. Harsch, deputy associate director of the Office of Management and Budget, will speak at the luncheon on the President's reorganization of federal responsibilities for resource and environmental management.

The regular meeting of the Missouri River Basin Commission will begin at 2:30 p.m. Wednesday, May 24. It will conclude by noon Thursday, May 25.

Federal and interstate compact members of the commission in addition to the 10 states listed above are the Department of Agriculture; Department of the Army; Department of Commerce; Department of Energy; Environmental Protection Agency; Department of Health, Education and Welfare; Department of Housing and Urban Development; Department of the Interior; Department of Transportation; the Yellowstone River Compact Commission; and the Big Blue River Compact Administration.

The presidentially appointed chairman of the commission also is a voting member. The MRBC chairmanship has been vacant since the resignation of John W. Neuberger Oct. 26.

Vice-Chairman John E. Acord of Montana will preside at the 24th commission meeting in the absence of a chairman.
